SIXTH SUPPLEMENTAL DECLARATION TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF RESERVE AT SAWGRASS

This Sixth Supplemental Declaration to Declaration of Covenants, Conditions and Restrictions of Reserve at Sawgrass (this "Supplemental Declaration") is made and executed this 23 day of 10, 2017, by BEAZER HOMES, LLC, a Delaware limited liability company, as successor by conversion to Beazer Homes Corp., a Tennessee Corporation ("Developer" or "Beazer"), with an office at 2600 Maitland Center Parkway, Suite 265, Maitland, Florida 32751.

Recitals

- (A) Beazer is the Developer under that certain Declaration of Covenants, Conditions and Restrictions of Reserve at Sawgrass recorded on November 25, 2013, in Official Records Book 10668, Page 6145 of the public records of Orange County, Florida, as may have been supplemented and amended from time to time (collectively, the "**Declaration**");
- (B) Section 4 of the Declaration allows Developer, without joinder or consent of any other party, to amend the Declaration to submit any portion of the "Additional Property" (as defined in the Declaration) to become a part of the "Property" (as defined in the Declaration) subject to the Declaration;
- (C) Developer is the owner of that certain property in Orange County, Florida, described in <u>Exhibit "A"</u> attached hereto and, by this reference, made a part hereof (the "**Phase 4C Property**"), which constitutes a portion of the Additional Property;
- (D) In connection with the subdivision and development of the Phase 4C Property, Developer has recorded, or will record, a plat for Reserve at Sawgrass, Phase 4C (the "Phase 4C Plat") covering the Phase 4C Property, in the Public Records of Orange County, Florida; and
- (E) In connection with the recording of the Phase 4C Plat, Developer desires to submit the Phase 4C Property to become a part of the Property subject to the Declaration.

NOW, THEREFORE, the Developer hereby agrees and covenants as follows:

1. <u>Recitals</u>. The above recitals of facts are true and correct and, by this reference, are made a part of the operative terms of this Supplemental Declaration.

- 2. <u>Submission of Phase 4C Property</u>. The Developer, for itself and its successors, grantees and assigns, hereby makes, declares and publishes its intention to submit, and does hereby submit, the Phase 4C Property to be a part of the Property.
- 3. <u>Subject to Declaration</u>. The Phase 4C Property shall be subject to all of the covenants, conditions, restrictions, easements, and other terms and provisions contained in the Declaration, as may be amended and supplemented from time to time.
- 4. <u>Common Area.</u> Pursuant to the Phase 4C Plat and the Declaration, as may be amended and supplemented from time to time, the following tracts and easement areas as depicted on the Phase 4C Plat shall constitute a part of the "Common Area" as defined in the Declaration: (a) Tracts "A" and "B" which are designated as Open Space on the Phase 4C Plat, (b) the Wall and Landscape Easement (W.L.E.), and (c) the Homeowners Association Drainage Easement (H.O.A.D.E.).
